UNTIL FURTHER INSTRUCTED, CONTINUE TO SUSPEND LIQUIDATION FOR ENTRIES COVERED BY INJUNCTION MESSAGE NUMBER 5136211 DATED MAY 16, 2005, AND INJUNCTION MESSAGE NUMBER 6031201 ON JANUARY 31, 2006, WHICH WAS AMENDED BY MESSAGE NUMBER 6188203 ON JULY 7, 2006, AND MESSAGE NUMBER 6188203 WAS AMENDED BY MESSAGE NUMBER 6199202 ON JULY 18, 2006.

2. ALTHOUGH COMMERCE INITIATED AN ADMINISTRATIVE REVIEW OF THE

ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD JUNE 24, 2004 THROUGH DECEMBER 31, 2005 FOR VARIOUS COMPANIES ON MARCH 7, 2006, 71 FR 11394, IT HAS RESCINDED THE REVIEW FOR CERTAIN EXPORTERS (71 FR 37539, JUNE 30, 2006).

THEREFORE, YOU ARE TO ASSESS ANTIDUMPING DUTIES ON MERCHANDISE MANUFACTURED OR EXPORTED BY THE COMPANIES LISTED BELOW THAT WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION AT THE CASH DEPOSIT OR BONDING RATE IN EFFECT ON THE DATE OF ENTRY, EXCEPT FOR ENTRIES COVERED BY PARAGRAPH ONE.

3. ENTRIES COVERED BY PARAGRAPH TWO WITH ENTRY DATES DURING THE PERIOD DECEMBER 21, 2004 THROUGH DECEMBER 27, 2004, SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES.

4. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF THE MERCHANDISE FOR THE PERIOD AND FIRMS COVERED BY PARAGRAPH TWO ABOVE OCCURRED WITH THE PUBLICATION OF THE PARTIAL RESCISSION OF THE ADMINISTRATIVE REVIEW (71 FR 37539 (JUNE 30, 2006)).

5. DO NOT LIQUIDATE ENTRIES OF MERCHANDISE OF FIRMS NOT LISTED IN PARAGRAPH TWO UNTIL YOU RECEIVE SPECIFIC INSTRUCTIONS AFTER THE COMPLETION OF THE ADMINISTRATIVE REVIEW. CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES OF MERCHANDISE EXPORTED OR PRODUCED BY FIRMS NOT LISTED ABOVE AND ENTERED, OR WITHDRAWN FROM WAREHOUSE,

FOR CONSUMPTION DURING THE PERIOD JUNE 24, 2004 THROUGH DECEMBER 31, 2005.

6. YOU SHALL CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR SUBSEQUENT ENTRIES OF THE SUBJECT MERCHANDISE AT THE CURRENT RATES.

7. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED

ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

8. UPON ASSESSMENT OF ANTIDUMPING DUTIES, CBP SHOULD REQUIRE THAT THE IMPORTER PROVIDE A REIMBURSEMENT STATEMENT AS DESCRIBED IN SECTION 351.402(f)(2) OF THE COMMERCE DEPARTMENT REGULATIONS. THE IMPORTER SHOULD PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO

LIQUIDATION OF THE ENTRY. IF THE IMPORTER CERTIFIES THAT IT HAS AN AGREEMENT WITH THE EXPORTER TO BE REIMBURSED ANTIDUMPING DUTIES, CBP SHOULD DOUBLE THE ANTIDUMPING DUTIES IN ACCORDANCE WITH THE ABOVE-REFERENCED REGULATION. ADDITIONALLY, IF THE IMPORTER DOES NOT RESPOND TO YOUR FORMAL REQUEST FOR THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION, CBP SHOULD PRESUME REIMBURSEMENT AND DOUBLE THE ANTIDUMPING DUTIES DUE.
