1. ON JULY 3, 2006 (71 FR 37905), THE DEPARTMENT OF COMMERCE ("COMMERCE") PUBLISHED IN THE FEDERAL REGISTER ITS FINAL RESULTS OF THE ANTIDUMPING DUTY ADMINISTRATIVE REVIEW ON STAINLESS STEEL BAR FROM INDIA FOR THE PERIOD 02/01/2004 THROUGH 01/31/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN

REVISED FOR CHANDAN STEEL CO., LTD. (A-533-810-009). THEREFORE, FOR SHIPMENTS OF STAINLESS STEEL BAR FROM INDIA, ENTERED, OR
