ON 05/24/2006, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM (A-552-801), AND ENTERED DURING THE PERIOD 01/31/2003 THROUGH 07/31/2004 UNDER IMPORTER IDENTIFICATION NUMBER 77-0538057.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT

CASE NUMBER 06-00132 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION, UNDER IMPORTER IDENTIFICATION NUMBER 77-0538057 DURING THE PERIOD 01/31/2003 THROUGH 07/31/2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 07/20/2006. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF THE FIFTH BUSINESS DAY AFTER COPIES OF THIS ORDER ARE PERSONALLY SERVED TO THE APO DOCKET CENTER.
