1. UNTIL FURTHER INSTRUCTED, CONTINUE TO SUSPEND LIQUIDATION FOR  
ENTRIES COVERED BY INJUNCTION MESSAGE NUMBER 5066206 DATED  
03/07/2005.

2. THESE INSTRUCTIONS DO NOT SUPERCEDE THE INSTRUCTIONS IN  
MESSAGE NUMBER 4281205 DATED 10/07/2004. CONTINUE TO LIQUIDATE  
ENTRIES COVERED BY MESSAGE NUMBER 4281205 DATED 10/07/2004 AT THE  
RATE INDICATED IN THAT MESSAGE.

3. FOR ALL OTHER ENTRIES OF SHIPMENTS OF BBS AND SPHERICAL PLAIN BEARINGS FROM FRANCE PRODUCED BY SKF FRANCE S.A. OR SKF AEROSPACE FRANCE (FORMERLY KNOWN AS SARMA), ENTERED UNDER A-427-201-012, A-427-201-008, A-427-205-012, OR A-427-205-008 DURING THE PERIOD 05/01/2002 THROUGH 04/30/2003, AND NOT COVERED BY PARAGRAPHS ONE OR TWO, LIQUIDATE AT THE ALL-OTHERS RATE. THE ALL-OTHERS RATE FOR BALL BEARINGS AND PARTS THEREOF FROM FRANCE IS 65.13 PERCENT, AND THE ALL-OTHERS RATE FOR SPHERICAL PLAIN BEARINGS AND PARTS THEREOF FROM FRANCE IS 39.00 PERCENT.

4. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE DURING THE PERIOD 05/01/2002 THROUGH 04/30/2003 COVERED BY PARAGRAPH THREE OCCURRED WITH THE PUBLICATION OF THE FINAL RESULTS OF ADMINISTRATIVE REVIEW (69 FR 55574 (SEPTEMBER 15, 2004)). FOR ALL OTHER SHIPMENTS OF BALL BEARINGS AND SPHERICAL PLAIN BEARINGS FROM FRANCE YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY U.S. CUSTOMS AND BORDER PROTECTION (CBP) ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER WHICH IS MAY 15, 1989. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. UPON ASSESSMENT OF ANTIDUMPING DUTIES, CBP SHOULD REQUIRE THAT THE IMPORTER PROVIDE A REIMBURSEMENT STATEMENT AS DESCRIBED IN SECTION 351.402(f)(2) OF THE COMMERCE DEPARTMENT REGULATIONS.

THE IMPORTER SHOULD PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION OF THE ENTRY. IF THE IMPORTER CERTIFIES THAT IT HAS AN AGREEMENT WITH THE EXPORTER TO BE REIMBURSED ANTIDUMPING DUTIES, CBP SHOULD DOUBLE THE ANTIDUMPING DUTIES IN ACCORDANCE WITH THE ABOVE-REFERENCED REGULATION. ADDITIONALLY, IF THE IMPORTER DOES NOT RESPOND TO YOUR FORMAL REQUEST FOR THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION, CBP SHOULD PRESUME REIMBURSEMENT AND DOUBLE THE ANTIDUMPING DUTIES DUE.
