1. ON 07/05/2006, THE INTERNATIONAL TRADE COMMISSION (ITC)
NOTIFIED THE DEPARTMENT OF COMMERCE OF ITS NEGATIVE FINAL
DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF DIAMOND
SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA. THE
ANTIDUMPING DUTY INVESTIGATION OF DIAMOND SAWBLADES AND PARTS
THEREOF FROM THE REPUBLIC OF KOREA HAS BEEN TERMINATED.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF

ALL SHIPMENTS OF SUBJECT MERCHANDISE PRODUCED AND/OR EXPORTED BY

EHWA DIAMOND INDUSTRIAL CO., LTD. (A-580-855-001), AND HYOSUNG DIAMOND INDUSTRIAL CO. (A-580-855-002), ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/29/2005. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ALL SHIPMENTS OF SUBJECT MERCHANDISE PRODUCED AND/OR EXPORTED BY SHINHAN DIAMOND INDUSTRIAL CO., LTD. (A-580-855-003), AND THE ALL OTHERS COMPANIES (A-580-855-000) ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 09/30/2005. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
