THE NOTICE OF INITIATION OF REVIEW WAS PUBLISHED IN THE FEDERAL REGISTER ON AUGUST 6, 1996.

2. FOR SHIPMENTS OF CERTAIN STAINLESS STEEL WIRE ROD FROM INDIA ENTERED, OR WITHDRAWN FOR WAREHOUSE, FOR CONSUMPTION IN THE U.S. ON OR AFTER AUGUST 6, 1996, A BOND OR OTHER SECURITY DEPOSIT IS

PERMITTED, AT THE IMPORTER'S OPTION, FOR THE FOLLOWING NEW MANUFACTURER/EXPORTERS:

5. THE OPTION OF A BOND IN LIEU OF A CASH DEPOSIT WILL REMAIN IN EFFECT FOR THE FIRM LISTED IN PARAGRAPH 2 UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEW SHIPPER ADMINISTRATIVE REVIEW.
