1. NOTICE THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE OCCURRED WITH THE PUBLICATION IN THE FEDERAL REGISTER ON JUNE 29, 2006 (71 FR 37056) OF THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-507-501) ON CERTAIN IN-SHELL (RAW) PISTACHIOS FROM IRAN FOR THE PERIOD JANUARY 1, 2004, THROUGH DECEMBER 31, 2004.

2. IMPORTS COVERED BY THE REVIEW ARE IN-SHELL PISTACHIO NUTS FROM WHICH THE HULLS HAVE BEEN REMOVED, LEAVING THE INNER HARD

SHELLS AND EDIBLE MEATS, FROM IRAN. THE MERCHANDISE UNDER REVIEW IS CURRENTLY CLASSIFIABLE UNDER ITEM 0802.50.20.00 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS). ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE IS DISPOSITIVE.

3. THE NET SUBSIDY WAS FOUND TO BE 71.10 PERCENT AD VALOREM FOR THE PERIOD JANUARY 1, 2004, THROUGH DECEMBER 31, 2004.

4. ACCORDINGLY, YOU ARE TO LIQUIDATE AT 71.10 PERCENT OF THE ENTERED VALUE ON ALL SHIPMENTS CERTAIN IN-SHELL (RAW) PISTACHIOS FROM IRAN, EXPORTED BY THE PRODUCERS/EXPORTERS LISTED BELOW, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JANUARY 1, 2004 AND ON OR BEFORE DECEMBER 31, 2004.

THE ASSESSMENT OF COUNTERVAILING DUTIES BY THE U.S. CUSTOMS AND BORDER PROTECTION (CBP) ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. INTEREST SHALL BE CALCULATED FROM THE ENTRY DATE OR DATE OF DEPOSIT WHICHEVER IS LATER, OR ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THE MERCHANDISE LISTED ABOVE EXPORTED ON OR BEFORE 12/31/2004 IS LIFTED. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THE MERCHANDISE LISTED ABOVE EXPORTED AFTER 12/31/2004 WILL CONTINUE.
