1. ON JULY 24, 2006, IN MESSAGE NUMBER 6205204, THE DEPARTMENT
OF COMMERCE ISSUED LIQUIDATION INSTRUCTIONS FOR ALL ENTRIES FROM
FAIRMONT DESIGNS, INC., DONGGUAN SUNRISE FURNITURE CO., TAICANG
SUNRISE WOOD INDUSTRY CO., LTD., AND SHANGHAI SUNRISE FURNITURE
CO., LTD., FOR THE PERIODS JUNE 24, 2004 THROUGH DECEMBER 20,
2004, AND DECEMBER 28, 2004 THROUGH DECEMBER 31, 2005.

2. ON AUGUST 11, 2006, THE U.S. COURT OF INTERNATIONAL TRADE

ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890), PRODUCED AND/OR EXPORTED TO THE UNITED STATES BY FAIRMONT DESIGNS, INC., DONGGUAN SUNRISE FURNITURE CO., TAICANG SUNRISE WOOD INDUSTRY CO., LTD., AND SHANGHAI SUNRISE FURNITURE CO., LTD., THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JUNE 24, 2004 THROUGH AND INCLUDING SEPTEMBER 8, 2004.

3. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00249 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

4. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED AND/OR EXPORTED TO THE

UNITED STATES BY FAIRMONT DESIGNS, INC., DONGGUAN SUNRISE FURNITURE CO., TAICANG SUNRISE WOOD INDUSTRY CO., LTD., AND SHANGHAI SUNRISE FURNITURE CO., LTD., THAT WERE ENTERED, OR

WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JUNE 24, 2004 THROUGH AND INCLUDING SEPTEMBER 8, 2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON AUGUST 15, 2006. PURSUANT TO THE TERMS OF THE INJUNCTION ORDER, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 PM AFTER THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THE ORDER WERE SERVED ON THE DEPARTMENT OF COMMERCE.
