1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 40692) ON 07/18/2006 THE FINAL RESULTS OF NEW SHIPPER REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON FRESH GARLIC FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 11/01/2004 THROUGH 04/30/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN EXPORTER/PRODUCER COMBINATIONS. THEREFORE, FOR SHIPMENTS OF FRESH GARLIC FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/18/2006, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER/PRODUCER COMBINATIONS:

CASE NUMBER: A-570-831-025 DEPOSIT RATE: 00.00%

EXPORTER: SHENZHEN FANHUI IMPORT AND EXPORT CO., LTD.

PRODUCER: SHENZHEN FANHUI IMPORT AND EXPORT CO., LTD.

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE EXPORTER/PRODUCER COMBINATION LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE PRC OR NON-PRC EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE APPLICABLE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. FOR ALL PRC EXPORTERS OF SUBJECT MERCHANDISE WHICH HAVE NOT BEEN FOUND TO BE ENTITLED TO A SEPARATE RATE, THE CASH-DEPOSIT RATE WILL BE THE PRC-WIDE RATE OF 376.67 PERCENT.

C. FOR ALL NON-PRC EXPORTERS OF SUBJECT MERCHANDISE WHICH HAVE NOT RECEIVED THEIR OWN RATE, THE CASH-DEPOSIT RATE WILL BE THE RATE APPLICABLE TO THE PRC EXPORTER THAT SUPPLIED THAT NON-PRC EXPORTER.

4. EFFECTIVE 07/18/2006, IMPORTERS MAY NO LONGER POST A BOND OR OTHER SECURITY IN LIEU OF A CASH DEPOSIT ON IMPORTS OF FRESH GARLIC EXPORTED AND PRODUCED BY SHENZHEN FANHUI IMPORT AND EXPORT CO., LTD.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
