1. ON 08/23/2006, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON MALLEABLE IRON PIPE FITTINGS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-881), EXPORTED TO OR IMPORTED INTO THE UNITED STATES BY CHENGDE MALLEABLE IRON GENERAL FACTORY FOR THE PERIOD 12/02/2003 THROUGH 11/30/2004.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00259 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED TO OR IMPORTED INTO THE UNITED STATES BY CHENGDE MALLEABLE IRON GENERAL FACTORY AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION

DURING THE PERIOD 12/02/2003 THROUGH 11/30/2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 08/24/2006 PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THE ORDER ARE PERSONALLY SERVED TO THE DEPARTMENT OF COMMERCE.
