ON 08/29/2006, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM JAPAN WHICH: (1) WERE EXPORTED FROM JAPAN BY NIPPON SEIKO K.K. LTD. (NSK) (A-588-201-008), AND IMPORTED BY NSK CORPORATION, NSK PRECISION AMERICA, INC., OR ANOTHER COMPANY AFFILIATED WITH NSK; (2) WERE PRODUCED OR EXPORTED FROM JAPAN BY NIPPON SEIKO K.K. LTD. (NSK) AND IMPORTED

BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) THE FIRMS LISTED IN THE LIQUIDATION INSTRUCTIONS COVERED BY PARAGRAPH 1 OF MESSAGE NUMBER 6222208 DATED 08/10/2006; (3) WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2004 THROUGH 04/30/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00272 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH: (1) WERE EXPORTED FROM JAPAN BY NIPPON SEIKO K.K. LTD. (NSK)(A-588-201-008), AND IMPORTED BY NSK CORPORATION, NSK PRECISION AMERICA, INC., OR ANOTHER COMPANY AFFILIATED WITH NSK; (2) WERE PRODUCED OR EXPORTED FROM JAPAN BY NIPPON SEIKO K.K. LTD. (NSK) AND IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) THE FIRMS LISTED IN THE LIQUIDATION INSTRUCTIONS COVERED BY

PARAGRAPH 1 OF MESSAGE NUMBER 6222208 DATED 08/10/2006; (3) WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2004 THROUGH 04/30/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL FURTHER INSTRUCTED.

4. CONTINUE TO LIQUIDATE ENTRIES COVERED BY PARAGRAPH 2 OF MESSAGE NUMBER 6222208 AT THE ALL-OTHERS RATE IN EFFECT ON THE DATE OF ENTRY WHICH IS 45.83 PERCENT.

5. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO 08/29/2006 INJUNCTION.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 08/29/2006. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON THE FIFTH BUSINESS DAY FOLLOWING

THE DAY ON WHICH COPIES OF THE ORDER ARE PERSONALLY SERVED TO THE APO DOCKET CENTER AT COMMERCE.
