THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 54269) ON 9/14/06, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON HEAVY FORGED HAND TOOLS (AXES/ADZES) FROM THE PRC FOR THE PERIOD 02/01/04 THROUGH 01/31/05.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF HEAVY FORGED HAND TOOLS (AXES/ADZES) FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER

9/14/06, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. THE CASH DEPOSIT RATES FOR THE REVIEWED COMPANIES WILL BE THE

RATES SHOWN ABOVE.

B. FOR ANY PREVIOUSLY REVIEWED OR INVESTIGATED PRC OR NON-PRC EXPORTER, NOT COVERED IN THIS REVIEW, WITH A SEPARATE RATE, THE CASH DEPOSIT RATE WILL BE THE COMPANY-SPECIFIC RATE ESTABLISHED IN THE MOST RECENT SEGMENT OF THOSE PROCEEDINGS.
