PROTECTION SHALL CONTINUE TO SUSPEND LIQUIDATION OF SUCH  
SHIPMENTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR  
CONSUMPTION ON OR AFTER 07/16/2004. EFFECTIVE  
08/17/2006 CBP SHALL REQUIRE A CASH DEPOSIT EQUAL TO THE
