ON 09/11/2006, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF (BBS) FROM JAPAN WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BY JTEKT CORPORATION

(FORMERLY KNOWN AS KOYO SEIKO CO., LTD.) (A-588-201-005) AND KOYO CORPORATION OF U.S.A., AS IDENTIFIED IN PARAGRAPH 1 OF THE

FINAL LIQUIDATION INSTRUCTIONS DATED 08/10/2006 (MESSAGE NUMBER 6222207) DURING THE PERIOD 05/01/2004 THROUGH 04/30/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00250 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BY JTEKT CORPORATION AND KOYO CORPORATION OF U.S.A., AS IDENTIFIED IN PARAGRAPH 1 OF THE FINAL LIQUIDATION INSTRUCTIONS DATED 08/10/2006 (MESSAGE NUMBER 6222207) DURING THE PERIOD 05/01/2004 THROUGH 04/30/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY PARAGRAPH 1 OF MESSAGE NUMBER 6222207 DATED 08/10/2006.

5. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. CONTINUE TO LIQUIDATE ENTRIES COVERED BY PARAGRAPH 2 OF MESSAGE NUMBER 6222207 DATED 08/10/2006 AT THE ALL-OTHERS RATE IN EFFECT ON THE DATE OF ENTRY. THE ALL-OTHERS RATE FOR BBS FROM JAPAN IS 45.83 PERCENT.

7. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 09/11/2006. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M.
