1. ON 08/11/2006, IN RESPONSE TO A REQUEST BY DOREL ASIA SRL
("DOREL"), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE
RULING THAT INFANT (BABY) CHANGING TABLES WITH DRAWERS OR DOORS
ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING
WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA
(A-570-890).

2. BECAUSE THE INFANT (BABY) CHANGING TABLES WITH DRAWERS OR

DOORS ARE NOT DISTINGUISHABLE FROM IN-SCOPE MERCHANDISE, AND THE EXPECTATIONS OF THE END USER AND ULTIMATE USE OF CHANGING TABLES WITH DRAWERS AND DOORS ARE ALSO NOT DISTINGUISHABLE FROM A DRESSER AND OTHER IN-SCOPE MERCHANDISE, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE FROM THE PRC, INCLUDING DOREL'S INFANT (BABY) CHANGING TABLES WITH DRAWERS OR DOORS, LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PRC.
