RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM CHINA - KOHL'S SANTA HEAD CANDLE IS WITHIN SCOPE (A-570-504)

1. ON 08/25/2006, IN RESPONSE TO A REQUEST BY KOHL'S DEPARTMENT STORES, INC. (KOHL'S), THE DEPARTMENT OF COMMERCE (THE DEPARTMENT) ISSUED A FINAL SCOPE RULING THAT KOHL'S SANTA HEAD CANDLE (ITEM NUMBER L30169) IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCT IS NOT A RECOGNIZABLE OBJECT WHEN VIEWED FROM MOST ANGLES, THE DEPARTMENT FOUND THESE PRODUCTS TO

BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING THE KOHL'S SANTA HEAD CANDLE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, DESIGNATED IN PARAGRAPH 1.
