1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 26329) ON 05/04/2006 THE FINAL RESULTS OF NEW SHIPPER REVIEW OF THE ANTIDUMPING ORDER ON FRESH GARLIC FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 11/01/2003 THROUGH 10/31/2004.

2. FOR THE FOLLOWING SHIPMENTS OF FRESH GARLIC FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR

AFTER 05/04/2006, U.S. CUSTOMS AND BORDER PROTECTION (CBP) SHALL REQUIRE A CASH DEPOSIT AS STATED BELOW FOR SUCH ENTRIES.

BUT NOT PRODUCED BY HENAN XIANGCHENG SUNNY (SAN LI) FOODSTUFF FACTORY, ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/04/2006, CBP SHALL REQUIRE A CASH DEPOSIT OF 376.67 PERCENT OF THE ENTERED VALUE.

4. FOR ALL OTHER COMPANIES NAMED IN THE AD/CVD MODULE, THE CASH DEPOSIT RATE IS THE RATE PROVIDED THEREIN EXCEPT FOR GROWER AND EXPORTER COMBINATIONS INVOLVED IN ONGOING NEW SHIPPER REVIEWS (IN WHICH CASE THE AD/CVD MODULE SPECIFIES THAT A BOND OR OTHER SECURITY DEPOSIT IS PERMITTED). FOR ALL GROWERS OR EXPORTERS OF FRESH GARLIC FROM THE PRC, WHICH DO NOT HAVE A SPECIFIC RATE IN THE MODULE, THE CASH DEPOSIT RATE CONTINUES TO BE 376.67 PERCENT. FOR ALL NON-PRC EXPORTERS OF FRESH GARLIC FROM THE PRC, THE CASH DEPOSIT RATE WILL BE THE RATE APPLICABLE TO THE PRC GROWER OF THAT EXPORTER.

5. EFFECTIVE 05/04/2006, IMPORTERS MAY NO LONGER POST A BOND OR OTHER SECURITY IN LIEU OF A CASH DEPOSIT ON IMPORTS OF FRESH GARLIC EXPORTED BY SHANGHAI LJ INTERNATIONAL TRADING CO., LTD. AND PRODUCED BY HENAN XIANGCHENG SUNNY (SAN LI) FOODSTUFF FACTORY.

6. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS NEW SHIPPER REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
