1. ON AUGUST 15, 2006, IN MESSAGE NUMBER 6227203, THE DEPARTMENT
OF COMMERCE ISSUED INJUNCTION INSTRUCTIONS FOR ALL ENTRIES
EXPORTED FROM RUI FENG WOODWORK (DONGGUAN) CO., RUI FENG LUMBER
DEVELOPMENT (SHENZHEN) CO., LTD., AND DORBEST LIMITED AND
IMPORTED BY AMERICAN SIGNATURE, INC., FOR THE PERIODS JUNE 24,
2004 THROUGH AUGUST 4, 2004 AND NOVEMBER 17, 2004 THROUGH
JANUARY 3, 2005, BUT EXCLUDING ENTRIES MADE BETWEEN DECEMBER 21,
2004 AND DECEMBER 27, 2004. THIS MESSAGE MODIFIES MESSAGE

NUMBER 6227203 BY ALSO CONTINUING SUSPENSION OF LIQUIDATION ON ENTRIES MADE BETWEEN AUGUST 5, 2004 AND NOVEMBER 16, 2004.

2. HOWEVER, ON SEPTEMBER 14, 2006, THE U.S. COURT OF INTERNATIONAL TRADE MODIFIED THE PRELIMINARY INJUNCTION (SEE MESSAGE NUMBER 6227203) ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890), EXPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA TO THE UNITED STATES BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD, OR RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD. AND IMPORTED BY AMERICAN SIGNATURE, INC., THAT WERE ENTERED FOR CONSUMPTION IN THE UNITED STATES BETWEEN JUNE 24, 2004 THROUGH JANUARY 3, 2005, BUT EXCLUDING ENTRIES MADE BETWEEN DECEMBER 21, 2004 AND DECEMBER 27, 2004, AS DISCUSSED IN PARAGRAPH 1, ABOVE.

3. THIS INJUNCTION AS MODIFIED BY THE U.S. COURT OF INTERNATIONAL TRADE ON SEPTEMBER 14, 2006, WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00252 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE IN PARAGRAPH 2.

4. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS EXPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA TO THE UNITED STATES BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD, OR RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD. AND IMPORTED BY AMERICAN SIGNATURE, INC., THAT WERE ENTERED FOR CONSUMPTION IN THE UNITED STATES BETWEEN JUNE 24, 2004 THROUGH JANUARY 3, 2005, BUT EXCLUDING ENTRIES MADE BETWEEN DECEMBER 21, 2004 AND DECEMBER 27, 2004 AS NOTED IN PARAGRAPH 2. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES EXCEPT FOR ENTRIES MADE BETWEEN DECEMBER 21, 2004 AND DECEMBER 27, 2004 UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE

REFERENCED INJUNCTION ON SEPTEMBER 18, 2006. PURSUANT TO THE TERMS OF THE INJUNCTION ORDER, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 PM AFTER THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THE ORDER WERE SERVED ON THE DEPARTMENT OF COMMERCE.
