THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER ON 10/04/2006 (71 FR 58579) ITS NOTICE OF RESCISSION OF THE NEW SHIPPER REVIEW OF THE ANTIDUMPING DUTY ORDER (A-570-863) ON HONEY FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 12/01/2004 THROUGH 05/31/2005 FOR WUHAN SHINO-FOOD TRADE CO., LTD. AS THE DEPARTMENT HAS NOW DETERMINED TO RESCIND THE NEW SHIPPER REVIEW, WUHAN SHINO-FOOD TRADE CO., LTD. IS NOT ENTITLED TO A SEPARATE RATE AND IT REMAINS PART OF THE PRC

ENTITY. CUSTOMS AND BORDER PROTECTION SHOULD THEREFORE COLLECT A CASH DEPOSIT FOR ALL FUTURE ENTRIES MADE BY WUHAN SHINO-FOOD TRADE CO., LTD. AT THE PRC-WIDE RATE (212.39 PERCENT).

2. AS A RESULT OF COMMERCE'S RESCISSION, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN PRODUCER/EXPORTER COMBINATIONS. THEREFORE, FOR SHIPMENTS OF HONEY FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 10/04/2006 THE REVISED CASH DEPOSIT FOR THE FOLLOWING PRODUCER/EXPORTER COMBINATION IS AS FOLLOWS:

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE PRODUCED OR EXPORTED BY A FIRM OTHER THAN THE PRODUCER/EXPORTER COMBINATION LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE PRC OR NON-PRC EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE APPLICABLE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. FOR ALL PRC EXPORTERS OF SUBJECT MERCHANDISE, WHICH HAVE NOT BEEN ASSIGNED TO A SEPARATE RATE, THE CASH-DEPOSIT RATE WILL BE THE PRC-WIDE RATE OF 212.39 PERCENT.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
