PER OUR E-MAIL OF 08/03/95, MESSAGE NO. 5215112, ON 07/07/95, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON COUMARIN FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 07/30/94 THROUGH THE PRESENT (A-570-830), MANUFACTURED OR EXPORTED BY TIANJIN NATIVE PRODUCE IMPORT AND EXPORT CORPORATION (TIANJIN) AND JIANGSU NATIVE PRODUCE IMPORT AND EXPORT CORPORATION (JIANGSU).

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY TIANJIN OR JIANGSU AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 07/30/94 THROUGH THE PRESENT. CONTINUE TO SUSPEND LIQUIDATION FOR TIANJIN AND JIANGSU UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
