1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS FROM THE UNITED KINGDOM FOR THE PERIOD 05/01/94 THROUGH 04/30/95 (62 FR 2081).
2. FOR SHIPMENTS OF BALL BEARINGS AND PARTS THEREOF AND CYLINDRICAL ROLLER BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 1/15/97, A CASH DEPOSIT IS REQUIRED

BEARINGS AND PARTS THEREOF, THE CASH DEPOSIT REQUIRED IS 54.27 PERCENT. FOR ALL OTHER BRITISH MANUFACTURERS/EXPORTERS OF CYLINDRICAL ROLLER BEARINGS AND PARTS THEREOF, THE CASH DEPOSIT REQUIRED IS 43.36 PERCENT.

THEREFORE, COMMERCE DOES NOT INTEND TO ISSUE LIQUIDATION INSTRUCTIONS FOR BALL BEARINGS AND PARTS THEREOF AND CYLINDRICAL ROLLER BEARINGS AND PARTS THEREOF FOR THIS FIRM AND FOR THIS PERIOD.
