1. ON DECEMBER 23, 1996, MESSAGE # 7358112 LIQUIDATION INSTRUCTIONS WERE ISSUED COVERING THE APRIL 1, 1991 THROUGH MARCH 31, 1994 REVIEW PERIODS FOR LIVE SWINE FROM CANADA (C-122-404).
2. WE INADVERTENTLY STATED AN INCORRECT RATE IN PARAGRAPH 4 OF THE LIQUIDATIONS INSTRUCTIONS FOR LIVE SWINE FROM CANADA (C-122-404) FOR THE PERIOD APRIL 1, 1991 THROUGH MARCH 31, 1992. THE CORRECT RATE FOR LIQUIDATION IS CAN\$0.0597 PER

KILOGRAM. ACCORDINGLY, YOU ARE TO LIQUIDATE AT CAN\$0.0597 PER KILOGRAM ON SHIPMENTS OF LIVE SWINE FROM CANADA, EXPORTED ON OR AFTER APRIL 1, 1991, AND ON OR BEFORE MARCH 31, 1992. THE RATES FOR THE OTHER REVIEW PERIODS (APRIL 1, 1992 THROUGH MARCH 31, 1993 AND APRIL 1, 1993 THROUGH MARCH 31, 1994) REMAIN UNCHANGED.
