1. ON FEBRUARY 5, 1997, THE U.S. COURT OF INTERNATIONAL TRADE
ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF
CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE
COUNTERVAILING DUTY ORDER OR FINDING ON CERTAIN IRON METAL
PRODUCTS FROM THE INDIA (C-533-063), MANUFACTURED OR
EXPORTED FOR THE PERIOD JANUARY 1, 1993 THROUGH DECEMBER 31,
1993.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JANUARY 1, 1993 THROUGH DECEMBER 31, 1993. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
