RE: NOTICE OF PRELIMINARY DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF FRESHWATER CRAWFISH FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-848)

1. ON MARCH 26, 1997, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER ITS PRELIMINARY DETERMINATION OF SALES AT LESS THAN FAIR VALUE IN THE ANTIDUMPING DETERMINATION OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-848).
2. THE PRODUCT COVERED BY THIS INVESTIGATION IS FRESHWATER CRAWFISH TAIL MEAT, (WHETHER WASHED OR WITH FAT ON, WHETHER

PURGED OR UNPURGED), IN ALL ITS FORMS, GRADES, AND SIZES; WHETHER FROZEN, FRESH, OR CHILLED; AND REGARDLESS OF HOW IT IS PACKED, PRESERVED, OR PREPARED. EXCLUDED FROM THE SCOPE OF THE INVESTIGATION ARE LIVE CRAWFISH AND OTHER WHOLE CRAWFISH, WHETHER BOILED, FROZEN, FRESH, OR CHILLED. ALSO EXCLUDED ARE SALTWATER CRAWFISH OF ANY TYPE, AND PARTS THEREOF. FRESHWATER CRAWFISH TAIL MEAT IS CURRENTLY CLASSIFIABLE IN THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTS) UNDER ITEM NUMBERS 0306.19.00.10 AND 0306.29.00.00. THE HTS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES ONLY. THE WRITTEN DESCRIPTION OF THE SCOPE OF THIS INVESTIGATION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-570-848.

4. THE CUSTOMS SERVICE WILL REQUIRE A CASH DEPOSIT OR POSTING OF A BOND EQUAL TO THE ESTIMATED DUMPING MARGINS BY WHICH THE NORMAL VALUE EXCEEDS THE U.S. PRICE, AS SHOWN BELOW. THESE SUSPENSION OF LIQUIDATION INSTRUCTIONS WILL REMAIN IN EFFECT UNTIL FURTHER NOTICE.

5. FOR IMPORTS OF FRESHWATER CRAWFISH TAIL MEAT, THE CUSTOMS SERVICE SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS THAT ARE ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MARCH 26, 1997. EFFECTIVE MARCH 26, 1997, CUSTOMS SHALL REQUIRE FOR SUCH ENTRY SUMMARIES, A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGIN RATES SHOWN BELOW:
