1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON LIVE SWINE FROM CANADA FOR THE APRIL 1, 1994 THROUGH MARCH 31, 1995 REVIEW PERIOD, AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON APRIL 14, 1997.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF LIVE SWINE, EXCEPT U. S. DEPARTMENT OF AGRICULTURE CERTIFIED PUREBRED

BREEDING SWINE, SLAUGHTER SOWS AND BOARS, AND WEANLINGS (WEANLINGS ARE SWINE WEIGHING UP TO 27 KILOGRAMS OR 59.5 POUNDS). THE MERCHANDISE SUBJECT TO THIS ORDER IS CLASSIFIABLE UNDER ITEM NUMBERS 0103.91.00 AND 0103.92.00 OF THE HARMONIZED TARIFF SCHEDULE (HTS).

3. ACCORDINGLY, FOR SHIPMENTS OF LIVE SWINE FROM CANADA, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER APRIL 14, 1997, YOU SHALL COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES OF CAN\$0.00 FOR ALL COMPANIES.
4. THIS CASH DEPOSIT REQUIREMENT WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRY SUMMARIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
