THE DEPARTMENT OF COMMERCE HAS AMENDED THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON CERTAIN WELDED CARBON STEEL PIPE AND TUBE FROM TURKEY FOR THE PERIOD OF MAY 1, 1994 THROUGH APRIL 30, 1995.
