ON APRIL 1, 1997, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY FINDING ON ROLLER CHAIN, OTHER THAN BICYCLE, FROM JAPAN (A-588-028-065), MANUFACTURED OR EXPORTED BY PULTON CHAIN CO., INC., FOR THE PERIOD APRIL 1, 1993 THROUGH APRIL 30, 1994.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR

EXPORTED BY PULTON CHAIN CO., INC. AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD APRIL 1, 1993 THROUGH APRIL 30, 1994. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
