ON 04/28/97, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON HEAVY FORGED HAND TOOLS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-201, 202, 203, 204), EXPORTED BY FUJIAN MACHINERY AND EQUIPMENT IMPORT AND EXPORT CORPORATION AND SHANDONG MACHINERY IMPORT AND EXPORT CORPORATION FOR THE PERIOD 02/01/94 THROUGH 01/31/95, AND CLASSIFIED UNDER HTSUS NUMBERS 8205.20.60, 8205.59.30, 8201.30.00, AND 8201.40.60.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS EXPORTED BY FUJIAN MACHINERY AND EQUIPMENT IMPORT AND EXPORT CORPORATION AND SHANDONG MACHINERY IMPORT AND EXPORT CORPORATION AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/94 THROUGH 01/31/95. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
