1. ON MAY 12, 1997, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER ITS PRELIMINARY DETERMINATION AND POSTPONEMENT OF FINAL DETERMINATION OF SALES AT LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF COLLATED ROOFING (CR) NAILS FROM KOREA, TAIWAN AND THE PEOPLE'S REPUBLIC OF CHINA.

2. THE PRODUCT COVERED BY THIS INVESTIGATION IS CR NAILS MADE OF STEEL, HAVING A LENGTH OF 13/16 INCH TO 1-13/16 INCHES (OR 20.64

TO 46.04 MILLIMETERS), A HEAD DIAMETER OF 0.330 INCH TO 0.415 INCH (OR 8.38 TO 10.54 MILLIMETERS), AND A SHANK DIAMETER OF 0.100 INCH TO 0.125 INCH (OR 2.54 TO 3.18 MILLIMETER), WHETHER OR NOT GALVANIZED, THAT ARE COLLATED WITH TWO WIRES.

CR NAILS WITHIN THE SCOPE OF THIS INVESTIGATION ARE CLASSIFIABLE UNDER THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS) SUBHEADING 7317.00.55.05 ALTHOUGH THE HTSUS SUBHEADING IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, OUR WRITTEN DESCRIPTION OF THE SCOPE OF THIS INVESTIGATION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES, THESE CASES HAVE BEEN ASSIGNED INVESTIGATION NUMBERS:

TAIWAN A-583-826

4. FOR IMPORTS OF COLLATED ROOFING NAILS, THE CUSTOMS SERVICE SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS THAT ARE ENTERED OR WITHDRAWN FROM WAREHOUSE, EXCEPT FOR THOSE BY KABOOL, UNICATCH, TOP UNITED, ZONGXUN, JUNHUA, AND PUDONG, FOR CONSUMPTION ON OR AFTER MAY 12, 1997.

EFFECTIVE MAY 12, 1997, CUSTOMS SHALL REQUIRE, FOR SUCH ENTRY SUMMARIES, A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE AD VALOREM MARGIN PERCENTAGES SHOWN BELOW:
