RE: CORRECTION OF MESSAGE 1140306 DATED 05/20/2011 CONCERNING THE ANTIDUMPING DUTY ORDER ON INNERSPRINGS FROM THE PRC (A-570-928)

1. THIS IS A CORRECTION OF PARAGRAPH 2 IN MESSAGE 1140306 DATED 05/20/2011.

2. ON JULY 19, 2012, THE COURT OF INTERNATIONAL TRADE (CIT) ISSUED A DECLARATORY JUDGEMENT IN FOSHAN NANHAI JIUJIANG QUAN LI SPRING HARDWARE FACT. ET AL. V. UNITED STATES ET AL., COURT NO. 12-00105 ("FOSHAN V. UNITED STATES") AND RULED THE DEPARTMENT OF COMMERCE'S LIQUIDATION INSTRUCTIONS IN MESSAGE 1140306 VOID AND OF NO LEGAL EFFECT, IN PART.

SPECIFICALLY, THE CIT RULED MESSAGE 1140306 VOID AND OF NO LEGAL EFFECT WITH REGARD TO THE EXPORTER FOSHAN YONGNUO IMPORT & EXPORT CO. LTD (A-570-928-009). ENTRIES FOR ALL OTHER FIRMS LISTED IN MESSAGE 1140306 SHOULD CONTINUE TO BE LIQUIDATED PURSUANT TO MESSAGE 1140306. THE CIT FURTHER RULED THAT LIQUIDATION OF FOSHAN YONGNUO IMPORT & EXPORT CO. LTD'S SINGLE ENTRY AT ISSUE IS VOID AND OF NO LEGAL EFFECT. ACCORDINGLY, ENTRIES OF SUBJECT MERCHANDISE EXPORTED BY FOSHAN YONGNUO IMPORT & EXPORT CO. LTD. (A-570-928-009), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2010-01/31/2011 SHOULD BE IN A SUSPENDED STATUS, I.E., SUSPENDED FROM LIQUIDATION.

3. PARAGRAPH 2 OF MESSAGE 1140306, INCLUSIVE OF FOSHAN YONGNUO IMPORT & EXPORT CO. LTD (A-570-928-009), CURRENTLY READS AS FOLLOWS:

THE LIQUIDATION AND CASH-DEPOSIT RATES FOR FIRMS WITH A NON-MARKET ECONOMY SEPARATE RATE, FOR WHICH AN ANTIDUMPING ADMINISTRATIVE REVIEW WAS NOT REQUESTED, WILL NOT BE REVISED FOR THIS PERIOD. THE FIRMS LISTED BELOW HAVE BOTH A NON-MARKET ECONOMY SEPARATE RATE AND ARE NOT SUBJECT TO THE REVIEW FOR THE PERIOD 02/01/2010-01/31/2011. THEREFORE, IN ACCORDANCE WITH SECTION 351.212(C) OF DEPARTMENT OF COMMERCE REGULATIONS, YOU ARE TO ASSESS ANTIDUMPING DUTIES ON MERCHANDISE ENTERED, OR WITHDRAWN FROM

WAREHOUSE, FOR CONSUMPTION FOR THE FIRMS LISTED BELOW AT THE CASH DEPOSIT OR BONDING RATE IN EFFECT AT THE TIME OF ENTRY.
