ON APRIL 9, 1997, THE INTERNATIONAL TRADE COMMISSION NOTIFIED THE DEPARTMENT OF COMMERCE OF ITS NEGATIVE FINAL DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF BRAKE DRUMS FROM THE PEOPLE'S REPUBLIC OF CHINA. THE ANTIDUMPING DUTY INVESTIGATION OF BRAKE DRUMS FROM THE PRC HAD BEEN TERMINATED.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ALL SHIPMENTS OF THIS MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER OCTOBER 10, 1996. ALL

ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRY SUMMARIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT 1930 DO NOT APPLY.
