1. ON JUNE 17, 1997, THE DEPARTMENT OF COMMERCE COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING ORDER ON POS COOKING WARE FROM THE PRC FOR THE PERIOD 12/01/94 THROUGH 11/30/95.
2. FOR SHIPMENTS OF POS COOKING WARE FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 6/17/97, A CASH DEPOSIT IS REQUIRED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

A-570-506-001 Clover Enamelware Enterprise Ltd./ 57.56%

Lucky Enamelware Factory Ltd.

A-570-506-000 PRC Wide 66.65%

3. IF ANY ENTRY OF THIS MERCHANDISE IS EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:
 - A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
