ON MAY 20, 1997 AND MAY 21, 1997, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED PRELIMINARY INJUNCTIONS ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601) FOR THE PERIODS JUNE 1, 1993 THROUGH MAY 31, 1994, AND JUNE 1, 1994 THROUGH MAY 31, 1995.

2. IN ITS MAY 21, 1997 PRELIMINARY INJUNCTION FOR THE PERIOD 6/1/93 THROUGH 5/31/94 (HEREAFTER THE TIMKEN 93/94 INJUNCTION) THE CIT ENJOINED THE LIQUIDATION OF ALL ENTRIES OF THIS MERCHANDISE FOR THIS PERIOD.

3. ACCORDINGLY, PURSUANT TO THE TIMKEN 93/94 INJUNCTION, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY ANY FIRM AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JUNE 1, 1993 THROUGH MAY 31, 1994.

IN ITS MAY 20, 1997, PRELIMINARY INJUNCTION FOR THE PERIOD 6/1/93 THROUGH 5/31/94 (HEREAFTER THE TRANSCOM 93/94 INJUNCTION) THE CIT ENJOINED THE LIQUIDATION OF ENTRIES OF THIS MERCHANDISE THAT WERE MADE BY OR ON BEHALF OF TRANSCOM, INC. AND WHICH WERE EXPORTED BY DIRECT SOURCE INTERNATIONAL OR GOLDHILL INTERNATIONAL TRADING & SERVICES CO.

ACCORDINGLY, PURSUANT TO THE TRANSCOM 93/94 INJUNCTION, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED BY OR ON BEHALF OF TRANSCOM INC., AND WHICH WERE EXPORTED BY DIRECT SOURCE INTERNATIONAL OR GOLDHILL INTERNATIONAL TRADING & SERVICES CO., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JUNE 1, 1993 THROUGH MAY 31, 1994.

6. IN ITS MAY 21, 1997 PRELIMINARY INJUNCTION FOR THE PERIOD 6/1/94 THROUGH 5/31/95 (HEREAFTER THE TIMKEN 94/95 INJUNCTION) THE CIT ENJOINED THE LIQUIDATION OF ALL ENTRIES OF THIS MERCHANDISE FOR THIS PERIOD.

7. ACCORDINGLY, PURSUANT TO THE TIMKEN 94/95 INJUNCTION, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY ANY FIRM AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JUNE 1, 1994 THROUGH MAY 31, 1995.

8. IN ITS MAY 20, 1997 PRELIMINARY INJUNCTION FOR THE PERIOD 6/1/94 THROUGH 5/31/95 (HEREAFTER THE TRANSCOM 94/95 INJUNCTION) THE CIT ENJOINED THE LIQUIDATION OF ENTRIES OF THIS MERCHANDISE THAT WERE MADE BY OR ON BEHALF OF TRANSCOM, INC., AND WHICH WERE EXPORTED BY DIRECT SOURCE INTERNATIONAL OR GOLDHILL INTERNATIONAL TRADING & SERVICES CO.

ACCORDINGLY, PURSUANT TO THE TRANSCOM 94/95 INJUNCTION, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED BY OR ON BEHALF OF TRANSCOM, INC., AND WHICH WERE EXPORTED BY DIRECT SOURCE INTERNATIONAL OR GOLDHILL INTERNATIONAL TRADING & SERVICES CO., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JUNE 1, 1994 THROUGH MAY 31, 1995.
