1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW

OF THE ANTIDUMPING DUTY ORDER ON CERTAIN COLD-ROLLED CARBON STEEL
FLAT PRODUCTS FROM THE NETHERLANDS FOR THE PERIOD 08/01/94 THROUGH
07/31/95 (62 FR 18476, AMENDED BY 62 FR 32294).

2. FOR SHIPMENTS OF CERTAIN COLD-ROLLED CARBON STEEL FLAT PRODUCTS
FROM THE NETHERLANDS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR

CONSUMPTION, ON OR AFTER 04/15/97, A CASH DEPOSIT IS REQUIRED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

A-421-804 HOOGOVENS STAAL BV 4.94 PERCENT

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:
 - A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.
 - B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.
 - C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE, OR THE MANUFACTURER IS UNKNOWN, USE THE "ALL OTHERS" RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.
4. FOR ALL OTHER DUTCH MANUFACTURERS/EXPORTERS, THE CASH DEPOSIT REQUIRED IS 19.32 PERCENT.
5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
6. IF THERE ARE ANY QUESTIONS REGARDING THIS MATTER BY CUSTOMS OFFICERS, PLEASE CONTACT VIA E-MAIL, THROUGH THE APPROPRIATE SUPERVISORY CHANNELS, IMPORT OPERATIONS, ANTIDUMPING/COUNTERVAILING DUTY, USING THE ATTRIBUTE "HQ OAB."
