CONSUMPTION ON OR AFTER JULY 7, 1997. EFFECTIVE JULY 7, 1997,
CUSTOMS SHALL REQUIRE A CASH DEPOSIT EQUAL TO THE MARGIN RATES
STATED IN CUSTOMS EMAIL NUMBER 7183114.
