ON 02/27/97, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE FINAL RESULTS OF ADMINISTRATIVE REVIEWS OF THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM SWEDEN (61 FR 66472 AND AS AMENDED AT 62 FR 149) (A-401-201, A-401-203), PRODUCED, EXPORTED, OR IMPORTED INTO THE UNITED STATES BY THE FIRMS LISTED BELOW AND ANY PARTIES RELATED THERETO, DURING THE PERIOD 05/01/93

THROUGH 04/30/94:

AB SKF, SKF MEKANPRODUKTER AB, AND SKF SVERIGE (SKF-SWEDEN)
AND SKF USA INC.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED, EXPORTED, OR IMPORTED INTO THE UNITED STATES BY THE FIRMS LISTED ABOVE AND ANY PARTIES RELATED THERETO, AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/93 THROUGH 04/30/94. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
