1. This is a correction to Message 2221303 dated 08/08/2012 to correct the "RE" line, paragraph 1, paragraph 2, and the upload table appended to the end of the message.

2. The "RE" line in Message 2221303 omitted some words and incorrectly read as follows:

Re: Liquidation Instructions For Certain Frozen Warmwater Shrimp from The Socialist Republic of Vietnam Exported for The Period 02/01/2007 Through 01/31/2008 (A-552-802)

Instead, the "RE" line should read as follows:

Re: Liquidation Instructions For Certain Frozen Warmwater Shrimp from The Socialist Republic of Vietnam Manufactured and/or Exported for The Period 02/01/2007 through 01/31/2008 (A-552-802)

3. Paragraph 1 of Message 2221303 omitted some words and incorrectly read as follows:

On 05/30/2012, the U.S. Court of International Trade issued a final decision in the case of Amanda Foods (Vietnam) Ltd., et. al v. United States (Consol. Court No. 09-00431). As a result of this decision, the injunctions to which messages 0091305, 9303204 and 9302204 refer enjoining liquidation of entries which are subject to the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam for the period 02/01/2007 through 01/31/2008 exported by the exporters listed in the company details table appended to this message dissolved on 07/29/2012.

Instead, paragraph 1 should read as follows:

4. Paragraph 2 of Message 2221303 omitted some words and incorrectly read as follows:

For all shipments of certain frozen warmwater shrimp from the Socialist Republic of Vietnam exported by the exporters as listed in the company-details table appended to the bottom of this message, and entered, or withdrawn from warehouse, for consumption during the period 02/01/2007 through 01/31/2008, assess an antidumping liability of margin percent of the entered value.

Instead, paragraph 2 should read as follows:

For all shipments of certain frozen warmwater shrimp from the Socialist Republic of Vietnam manufactured and/or exported by the manufacturers and/or exporters as listed in the company-details table appended to the bottom of this message, and entered, or withdrawn from warehouse, for consumption during the period 02/01/2007 through 01/31/2008, assess an antidumping liability of margin percent of the entered value.

5. The upload table appended to Message 2221303 was incomplete because it did not contain the following company-specific case numbers: A-552-802-007, A-552-802-019, A-552-802-024, and A-552-802-029. Therefore, we have attached a corrected upload table to this correction message.
