1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE
REVIEW OF THE ANTIDUMPING DUTY ORDER ON CERTAIN FORGED
STAINLESS STEEL FLANGES FROM INDIA FOR THE PERIOD 02/09/94
THROUGH 01/31/95(61 FR 51263).

2. FOR SHIPMENTS OF CERTAIN FORGED STAINLESS STEEL FLANGES FROM
INDIA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION
ON OR AFTER OCTOBER 1, 1996, A CASH DEPOSIT IS REQUIRED FOR
THE FOLLOWING MANUFACTURER/EXPORTER:

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE ABOVE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECTIVE LICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
