ON AUGUST 30, 1996, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FRESH CUT FLOWERS FROM COLOMBIA, PRODUCED BY THE COMPANIES LISTED BELOW, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIODS 03/01/91 THROUGH 02/29/92, 03/01/92 THROUGH 02/28/93, AND 03/01/93 THROUGH 02/28/94:

ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE PRODUCED BY THE FIRMS LISTED ABOVE, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIODS FROM 03/01/91 THROUGH 02/29/92, 03/01/92 THROUGH 02/28/93, AND 03/01/93 THROUGH 02/28/94. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

IN ADDITION, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN INJUNCTION ENJOINING THE REQUIREMENT OF PAYMENT, OR OTHERWISE COLLECTION OF ANTIDUMPING DUTY DEPOSITS ON ANY ENTRIES OF FRESH-CUT FLOWERS FROM COLOMBIA SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FRESH CUT FLOWERS FROM COLOMBIA, PRODUCED OR IMPORTED BY THE FOLLOWING COMPANIES OF

"THE QUEEN'S FLOWERS GROUP", AS LISTED IN THE DEPARTMENT OF COMMERCE'S AUGUST 19, 1996, NOTICE OF FINAL RESULTS OF ANTIDUMPING DUTY ADMINISTRATIVE REVIEWS CONCERNING CERTAIN FRESH-CUT FLOWERS FROM COLOMBIA, AT RATES OTHER THAN THOSE INDICATED BELOW, WHICH RATES ARE THOSE IN EFFECT UNDER THE LAST COMPLETED ADMINISTRATIVE REVIEW, 59 FR 15159 (MARCH 31, 1994):
