THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS SECOND ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD OF DECEMBER 1, 1995 THROUGH NOVEMBER 30, 1996 AND PUBLISHED THESE FINAL RESULTS IN THE FEDERAL REGISTER ON JANUARY 7, 1998 (63 FR 779).

2. FOR SHIPMENTS OF CERTAIN CASED PENCILS FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE

U.S. ON OR AFTER JANUARY 7, 1998, A CASH DEPOSIT IS REQUIRED AS FOLLOWS:

PRC-WIDE RATE: A-570-827-000 53.65 PERCENT

4. FOR OTHER PREVIOUSLY REVIEWED COMPANIES NOT NAMED ABOVE, THE CASH DEPOSIT RATE IS THE RATE PROVIDED IN THE ANTIDUMPING/COUNTERVAILING DUTY MODULE.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
