1. ON OCTOBER 30, 1996, IN RESPONSE TO A REQUEST BY COST PLUS, INC., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FONDUE SET IMPORTED BY COST PLUS, INC. IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PORCELAIN-ON-STEEL COOKING WARE FROM TAIWAN (A-583-508).
2. BECAUSE THE IMPORTED PRODUCT IS USED FOR COOKING AND HEATING FOODS AND CONTAINS A NON-ELECTRIC HEATING ELEMENT, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE

SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRY SUMMARIES OF PORCELAIN-ON-STEEL COOKING WARE FROM TAIWAN, INCLUDING COST PLUS'S FONDUE SET LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PORCELAIN-ON-STEEL COOKING WARE FROM TAIWAN.
