1 ON AUGUST 23, 1996, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON CANNED PINEAPPLE FRUIT FROM THAILAND, (A-549-813), MANUFACTURED OR EXPORTED BY SIAM AGRO INDUSTRY PINEAPPLE AND OTHERS PUBLIC CO. (SAICO), AND MALEE SAMPRAN FACTORY PUBLIC CO., LTD. (MALEE).

2. PER COURT INSTRUCTION, SINCE NO ADMINISTRATIVE REVIEW HAS BEEN REQUESTED FOR SAICO AND MALEE, ENTRIES SHALL REMAIN ENJOINED AND BE SUBJECT TO THE ASSESSMENT OF ANTIDUMPING DUTIES ONLY AT THE TIME OF THE FINAL AND CONCLUSIVE COURT DECISION.
3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY SAICO AND MALEE AND WHICH WAS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JANUARY 11, 1995. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
4.
