ON NOVEMBER 19, 1996, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON CERTAIN PASTA FROM ITALY (A-475-818), MANUFACTURED OR EXPORTED BY RUMMO S.P.A. MOLINO E PASTIFICIO (RUMMO) AND LA MOLISANA INDUSTRIE ALIMENTARI S.P.A. (LA MOLISANA) FOR THE PERIOD MAY 19, 1996 THROUGH JULY 23, 1996.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY RUMMO AND LA MOLISANA AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 19, 1996 THROUGH JULY 23, 1996. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRY SUMMARIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
