1. ON APRIL 16, 1998, IN RESPONSE TO A REQUEST BY FUJI PHOTO FILM CO., LTD. AND FUJI PHOTO FILM U.S.A., INC. (FUJIFILM) AND SONY CORPORATION AND SONY ELECTRONICS INC. (SONY) THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT FUJIFILM'S AND SONY'S HIGH CAPACITY FLOPPY DISKS ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING 3.5 INCH MICRODISKS AND COATED MEDIA FROM JAPAN (A-588-802).

HIGH CAPACITY FLOPPY DISKS MERIT A NEGATIVE SCOPE RULING

BECAUSE OF A DIFFERENT DRIVE UTILIZED IN RETRIEVING DATA AS WELL AS THE INHERENT CHARACTERISTICS OF HIGH CAPACITY FLOPPY DISKS. THEREFORE, FUJIFILM'S AND SONY'S HIGH CAPACITY FLOPPY DISKS ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING 3.5 INCH MICRODISKS AND COATED MEDIA FROM JAPAN.

3. ACCORDINGLY, EFFECTIVE APRIL 16, 1998, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRY SUMMARIES, REGARDLESS OF ENTRY SUMMARY DATE, OF FUJIFILM'S AND SONY'S HIGH CAPACITY FLOPPY DISKS.
 4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE HIGH CAPACITY FLOPPY DISKS LISTED ABOVE.
 5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
 6. CONTINUE TO SUSPEND LIQUIDATION OF ENTRY SUMMARIES OF 3.5" MICRODISKS AND COATED MEDIA FROM JAPAN.
