1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS CHANGED CIRCUMSTANCES REVIEW OF THE ANTIDUMPING ORDER ON CIRCULAR WELDED

NON-ALLOY STEEL PIPE FROM THE REPUBLIC OF KOREA. THE DEPARTMENT OF COMMERCE HAS DETERMINED THAT THE SEAH STEEL CORPORATION (SEAH)

IS THE SUCCESSOR COMPANY OF PUSAN STEEL PIPE CO., LTD. (PSP). AS THE SUCCESSOR COMPANY OF PSP, SEAH IS, THEREFORE, ENTITLED TO THE CASH DEPOSIT RATE OF PSP.

2. FOR SHIPMENTS OF CIRCULAR WELDED NON-ALLOY STEEL PIPE BY SEAH FROM THE REPUBLIC OF KOREA ENTERED, OR WITHDRAWN FROM WAREHOUSE,

FOR CONSUMPTION ON OR AFTER APRIL 27, 1998, A CASH DEPOSIT IS REQUIRED AS FOLLOWS:

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW.
