ON MARCH 20, 1998, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION (COURT NO. 97-12-02117) ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING FINDING ON ROLLER CHAIN FROM JAPAN (A-588-028), MANUFACTURED BY ENUMA CHAIN MANUFACTURING COMPANY LTD., EXPORTED BY DAIDO TSUSHO COMPANY, LTD., AND IMPORTED BY DAIDO CORPORATION FOR THE PERIOD APRIL 1, 1995 THROUGH MARCH 31, 1996.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS MANUFACTURED BY ENUMA CHAIN MANUFACTURING COMPANY LTD., EXPORTED BY DAIDO TSUSHO COMPANY, LTD., AND IMPORTED BY DAIDO CORPORATION WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD APRIL 1, 1995 THROUGH MARCH 31, 1996. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
