ON APRIL 28, 1997, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM GERMANY (A-428-201, 203, 205) (62 FR 2081 AND AS AMENDED AT 62 FR 2130 AND 14391) PRODUCED BY, EXPORTED BY, OR IMPORTED INTO THE UNITED STATES BY THE FIRMS LISTED BELOW AND ANY PARTIES RELATED THERETO, DURING THE PERIOD MAY 1, 1994 THROUGH APRIL 30, 1995.

CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
