ON APRIL 28, 1997, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM JAPAN (A-588-201, A-588-203, A-588-205) (62 FR 2081 AND AS AMENDED AT 62 FR 14391) PRODUCED BY, EXPORTED BY, OR IMPORTED INTO THE UNITED STATES BY THE FIRMS LISTED BELOW AND ANY PARTIES RELATED THERETO, DURING THE PERIOD MAY 1, 1994 THROUGH APRIL 30, 1995:

KOYO SEIKO CO., LTD., KOYO CORPORATION OF U.S.A., AND THE
U.S. SUBSIDIARIES AND AFFILIATES (KOYO)
NIPPON PILLOW BLOCK MANUFACTURING CO., LTD., NIPPON PILLOW

ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED BY, EXPORTED BY, OR IMPORTED INTO THE UNITED STATES BY THE FIRMS LISTED ABOVE AND ANY PARTIES RELATED THERETO, AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 1994 THROUGH APRIL 30, 1995. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
