ON SEPTEMBER 27, 1997, IN RESPONSE TO A REQUEST BY ECKSTROM INDUSTRIES, INC., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT ECKSTROM'S CAST STAINLESS STEEL STUB END FITTINGS ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN STAINLESS STEEL BUTT-WELD PIPE FITTINGS FROM TAIWAN (A-583-816).

2. BECAUSE THE IMPORTED STAINLESS STEEL STUB-END PIPE FITTINGS ARE INCLUDED WITHIN THE SCOPE OF THE ORDER EO NOMINE, THE

COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CERTAIN STAINLESS STEEL BUTT-WELD PIPE FITTINGS, INCLUDING ECKSTROM'S CAST STAINLESS STEEL STUB-END FITTINGS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING CERTAIN STAINLESS STEEL BUTT-WELD PIPE FITTINGS FROM TAIWAN (A-583-816). STAINLESS STEEL BUTT-WELD PIPE FITTINGS ARE CURRENTLY CLASSIFIABLE UNDER SUBHEADINGS 7307.19.90.80 AND 7307.23.00.00 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES, ANNOTATED.
