2. FOR SHIPMENTS OF SEBACIC ACID FROM CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/13/1998, A CASH DEPOSIT IS REQUIRED FOR THE FOLLOWING
